Tiana's Murderer Sentenced to 60 years



On February 14th, 2009, James P. Carter murdered Tiana Angelique Notice. On January 13th, 2012, he was sentenced to serve 60 years in prison. For the nearly three years between Tiana's death and the sentencing, we posted updates on the court case against her murderer. The rest of this post details, update by update, how the process unfolded. While we are relieved to see justice done, it does
